The COD/COF Medication Safety Task Force was formed in July 2007 and consists of experts in medication safety in the areas of pharmacy education and practice. The task force charge was given by Drs. Brian Crabtree and Barbara Hayes, addressing the role of colleges and schools of pharmacy in responding to the national patient safety agenda. The task force decided that it could have the greatest impact by focusing on the issues surrounding medication safety. The task force was divided into three panels (with overlap of membership), dealing with 1) the scholarship of medication safety; 2) curricular content in medication safety; and 3) medication safety awareness.

<p>Identifying Collaborators</p>	<p>Michael Negrete, Executive Director of the Pharmacy Foundation of California (PFC), has given much thought to the issue of risk communication. The PFC commissioned the Bouchard Communications Group to assist in developing a strategy to increase awareness of medication safety issues among consumers. Throughout the next year, they will be testing communication strategies and messaging with targeted consumer groups. Dr. Negrete was added to our medication safety awareness panel. He will be a great ally as we further develop a medication safety awareness campaign that reaches our many stakeholders.</p> <p>Peter Sandman, Consultant, NJ, has created a scientifically based discipline related to risk communication. His focus has been primarily in the area of environmental risk and public perceptions of risk. He has noted that "the risks that kill people and the risks that alarm them are often completely different". Bob Weber and Dan Robinson had a 30 minute conference call with Dr. Sandman and extracted the following points:</p> <ul style="list-style-type: none"> • Awareness will depend on an "outrage-increasing" campaign. (perceived risk = hazard + outrage) • The public must see pharmacists as partners • Create a demand for increased professional interactions with pharmacists, coupled with payment mechanisms for such services • No health care providers are currently paid for activities associated with improving medication safety (excluding limited MTM services) • Target audience must include patients, payers, legislators, and health care providers. • Risk communication is most effective when 	<p>In process</p>	<p>Continue collaboration with Dr. Negrete and PFC to further develop medication safety message.</p> <p>Invite Dr. Sandman to address a broad AACP audience regarding risk communication.</p>
