

# PHARMACY FACULTY SURVEY PRIVATE SCHOOL SUMMARY REPORT - 2013

The Faculty Survey was available for online access in the AACP Centralized Survey System on March 11, 2013. As of July 2013, 56 private colleges and schools of pharmacy administered the survey to their faculty. One thousand, nine hundred and ninety-three (1,993) faculty at private schools were invited to complete the survey. One thousand, five hundred and thirty-five (1,535) faculty at private schools submitted the survey for a total response rate of seventy-seven percent (77.0%). Response rates per school ranged from 7.4 percent to 100.0 percent.
