

PHARMACY ALUMNI SURVEY SUMMARY REPORT - 2013

The Alumni Survey was available for online access in the AACP Centralized Survey System on May 6, 2013. As of September 2013, 52 out of 110 (47.3%) colleges and schools of pharmacy administered the survey to their 2008-2012 alumni classes. Sixteen thousand and fifty-three (16,053) alumni were invited to complete the survey. Two thousand, six hundred and eighty-eight (2,688) alumni submitted the survey for a total response rate of nearly seventeen percent (16.7%). Response rates per school ranged from 3.7 percent to 43.8 percent.
