## About the AACP Curriculum Quality Surveys

Graduating Student, Alumni, Preceptor, and Faculty surveys were first released in 2007 based on Standards 2007 with the purpose of helping member colleges and schools gather data for both continuous improvement and accreditation purposes. With the release of the Accreditation Council for Pharmacy Education (ACPE) Standards 2016, these curriculum quality perception surveys were revised by the AACP Institutional Research and Assessment Committee (IRAC), AACP staff, and ACPE staff in spring 2015 to reflect the changes in Standards 2016. The 2018 results reflect the third administration of these revised surveys

## 2018 Administration

The Preceptor Survey was made available for online access in the AACP Survey System on May 7, 2018. As of September 2018, 86 out of 142 ( $60.6 \%$ ) colleges and schools of pharmacy administered the survey to their preceptors. A total of 39,002 preceptors were invited to complete the survey. Seven thousand eight hundred and forty-one $(7,841)$ preceptors submitted the survey for a total response rate of over twenty percent (20.1\%). Response rates per school ranged from less than 2 percent to nearly 77 percent. ## 2018 Highlights

## Preceptor Workload and Resources

Nearly forty-five (44.9\%) of preceptors reported precepting less than three students during the past academic year for the college/school of pharmacy for which they were completing the survey. Nearly thirty percent (29.9\%) of preceptors reported precepting three to five students for the college/school of pharmacy. Nearly forty percent (39.9\%) of preceptors completing the survey precepted for only one institution. Nearly 96 percent ( $95.9 \%$ ) of preceptors strongly agreed or agreed that the student-to-preceptor ratios at their sites were appropriate to maximize learning. Over ninety-four percent ( $94.4 \%$ ) of preceptors strongly agreed or agreed that the facilities and resources at the practice site are adequate in order to precept students. Nearly eighty-six percent ( $85.6 \%$ ) of preceptors strongly agreed or agreed that they had ongoing contact with the Office of Experiential Education.

## Curriculum and Communication

In 2018 over ninety-six percent ( $96.3 \%$ ) of preceptors strongly agreed or agreed that specific learning expectations for the student had been clearly defined for their rotation(s). Over ninety-six percent ( $96.5 \%$ ) strongly agreed or agreed that they knew how to use the assessment tools provided to measure student performance.

Over seventy-five percent (75.5\%) of preceptors completing the survey strongly agreed or agreed that they received the results from student evaluations of their rotation. However, over 18 percent (18.1\%) disagreed or strongly disagreed to receiving the results from students' evaluations of their rotation.
