



## **GRADUATING STUDENT SURVEY PRIVATE SCHOOL SUMMARY REPORT - 2013**

The Graduating Student Survey was available for online access in the AACCP Centralized Survey System on March 11, 2013. As of July 2013, 53 private colleges and schools of pharmacy graduating students in 2013 administered the survey to their students. Six thousand, five hundred and fifty (6,550) graduating students at private institutions were invited to complete the survey. Four thousand, seven hundred and twenty-three (4,723) graduating students at private institutions submitted the survey for a total response rate of over seventy-two percent (72.1%). Response rates per school ranged from 1.9 percent to 100.0 percent.
