AACP Environmental Opioid Scan: One Year Later

Updates

In February 2019, AACP launched its Opioid-Related Activities Database (www.aacp.org/opioid) after the initial environmental scan of opioid-related activities.

• Users can search the database using the following filters: General Search Bar, Institution Type, Program Structure, State, Type of Activity and Tags.

An additional 40+ activities have been reviewed and 4 new institutions have submitted activities since the last executive summary.

Category Breakdown of the 40+ Activities with Examples

• Education: 23 New Activities

Beginning in 2018, per the California Board of Pharmacy, second professional year students at California Northstate University received naloxone training. After completing this in-class training, student pharmacists can dispense naloxone without a physician's prescription, under the supervision of a trained pharmacist, and allows them to continue dispensing naloxone when they become licensed pharmacists. The activity is a 1-hour lecture and during the lecture, student pharmacists complete a worksheet covering all the pertinent information provided. When the student pharmacists finish, they have multiple applications that allow them to practice the skills they have learned, such as counseling and talking to their patients about this sensitive subject.

Research: 18 New Activities

In August 2016, the Illinois Department of Human Services (DHS) and Illinois Prescription Monitoring Program (PMP) engaged research faculty in the Department of Pharmacy Systems, Outcomes and Policy at the University of Illinois at Chicago College of Pharmacy to evaluate the impact of activities started as part of funding received through the Centers for Disease Control and Prevention Prescription Drug Overdose: Prevention for States program. These activities include 1) enhancing and maximizing prescription drug monitoring program use by moving towards universal PMP registration, increased ease of use and access of the PMP, real-time PMP reporting, and making local level statistical data available for surveillance and public dissemination and 2) implementing community or health system interventions by identifying and providing technical assistance to community service entities and evaluating prescriber and dispenser activities in high-burden areas.

Service: 13 New Activities

The University of Wisconsin–Madison provided expert support for the Naloxone Stand-Down Day at the William S Middleton VA, which used a concentrated telephone outreach to provide naloxone kits to at-risk veterans. This program reached 109 veterans and dispensed 82 naloxone kits subsequent to a single bout of telephone outreach by VA residents.


• Practice: 2 New Activities

In 2016, South Dakota State University formed an integrated Medication-Assisted Treatment (MAT) clinic to provide better integration of care services and care planning between counseling and medicine. The clinic consists of student pharmacists, medical students, family medicine residents, therapists, pharmacists, nurses, and physicians. The MAT integrated clinic team meets with patients early in care or after relapses in one team visit. Following the first few visits, the patient continues to be seen by the physician and pharmacist alone and counseling if the patient agrees.

Advocacy: 2 New Activities

Dr. Andy Coop, a faculty member at the University of Maryland School of Pharmacy testified to the U.S. Senate HELP Committee in February 2019 at a hearing titled "Managing Pain during the Opioid Crisis" found at www.help.senate.gov/hearings/managing-pain-during-the-opioid-crisis. The testimony was focused on 1) Alternatives to opioids for the treatment of pain; and 2) The proposal that pharmacists be DATA Waivered to allow enhanced access for patients to Medication-Assisted Treatment (MAT) services.

AACP designed and created a poster regarding the opioid data that was debuted at *Pharmacy Education* 2019. This poster was submitted and accepted for presentation at the 2020 Rx Drug Abuse & Heroin Summit in Nashville, TN.


